### OBJECTIVES:

- The objective of this checklist is to verify compliance to the Criteria listed in the Sabah Legality Standard as defined by Principles 1 - 4 for Sabah dated November 2020 (**SFD-TLAS-002**).
- Compliance is defined when all applicable criteria are observed to be compliant. A minor Gap to any indicator does not constitute non-compliance to a criterion. A Major Gap to any applicable indicator does reflect non-compliance to a criterion. Compliance with a criterion where multiple minor gaps are identified in indicators under the criterion may reflect non-compliance to the criterion.
- All issues identified under this standard shall be considered appropriate to the scale and degree of forestry operations undertaken by the parties under the agreement.

## Summary Information

### Overview of Licensee:

A Joint Venture Agreement dated 19/03/1996 was made between Sabah Forestry Development Authority (SAFODA), Resofocus Corporation Sdn. Bhd. and Begaraya Sdn. Bhd. to develop an Industrial Tree Plantation (ITP) covering an area of approximately 60,000 ha, situated in the District of Kota Marudu and Pitas.

On 6/02/1997, Begaraya Sdn. Bhd. entered into an agreement entitled "Tree Plantation and Forest Management Agreement" with the government of the State of Sabah to develop and manage all degraded forest lands within the licensed area.

On 25/09/2003, a supplemental agreement between SAFODA, Resofocus Corporation Sdn. Bhd. and Begaraya Sdn. Bhd. was made to understand that Begaraya Sdn. Bhd. shall undertake the tasks of extracting and processing all the residual timber and carry out replanting activities under the ITP programme within the licensed area.

Subsequently, in 2009, the management of Begaraya Sdn. Bhd. was taken over by Asian Forestry Company (Sabah) Sdn. Bhd. [Asian Forestry Company (Sabah)]. The project area of 64,113 ha straddles 2 political districts, i.e., Pitas (23,824.7 ha) and Kota Marudu (40,288.7 ha). Following area deductions of land titled areas (6,606 ha) and water catchment areas (3,482 ha) by the Land & Survey Department, the total gross area identified for plantation establishment was 54,026 ha. However, the land area for ITPs management was reduced further due to land claims by the local communities.

The land tenure for Tree Plantation and Forest Management Agreement is for 60 years commencing on 06/02/1997 that will be lapse on 05/02/2057.

Asian Forestry Company (Sabah) Sdn. Bhd. [Asian Forestry Company (Sabah)] is managed by Forest Solutions Malaysia Sdn. Bhd.

Asian Forestry Company (Sabah) has an approved Form 1 license from the SFD to conduct logging and planting activities.

As of the assessment, Asian Forestry Company (Sabah) have appointed several contractors to support the forestry activities inside the licensed area, as follows:

**\*Note:** Based on the 2<sup>nd</sup> FMP, total area of 89.70 hectares was planted within titled land. This area was initially planted by Asian Forestry Company (Sabah) before the land excision and the approval of the land title. Based on the management representative, the remaining 32 hectares serve as a buffer zone surrounding the planted trees. However, Asian Forestry Company (Sabah) identified the planted area as having potential only for future log production and not for a replanting program; thus, not included in the land use plan of the 2<sup>nd</sup> FMP.

### Current Operations:

Asian Forestry Company (Sabah) received approval from the SFD for salvage logging and planting on 23/07/2024, granting them permission to conduct forestry activities for five years. The license is set to expire on 22/07/2029.

Based on the 2024 AWP, Asian Forestry Company (Sabah) has targeted approximately 457 hectares for salvage logging and replanting activities within Coupe TC01. As of the assessment, about 70.06 hectares have been logged, and 10.70 hectares have been re-planted.

### Environmental Context:

Historically, numerous short-term licenses (mostly Form 1 License) were issued to logging contractors that carried out conventional logging activities. As a result of heavy impact logging, most of the forests in the project area are severely depleted and colonized by pioneer forest species dominating the residual forest area.

Elevation ranges from 160m to 800m asl. The topographical feature of the licensed area is as follows:

- 0° (Flat) 14%
- 0° – 12° 21%
- 13° – 18° 29%
- 19° – 25° 22%
- >25° 14%

The Sg. Bengkoka and its tributary, the Sg. Nibang drains the licensed area within the Pitas district into Marudu Bay. Whereas Sg Tandak, Sg. Menurodiang, Sg. Masalog and Sg. Kinaram drains the licensed area within the Marudu district into Marudu Bay.

A total of 3,482 ha of the licensed area has been mapped and set aside as water catchment.

Asian Forestry Company (Sabah) has discontinued planting *Acacia mangium* in their ITP area due to its susceptibility to fungal (*ceratocystis*) attacks. Given this, the Asian Forestry Company (Sabah) has selected the following tree species to be planted such as *Eucalyptus pelita*, *Acacia crassicarpa*, *Acacia aulacocarpa* and *Albizia falcataria*.

Asian Forestry Company (Sabah) engaged *Raleigh International* to assist in wildlife presence and identification in the licensed area in 2009. Wildlife sighted includes the Clouded leopard, Slow loris, Pangolin, Bearded pig, Sambar deer, Borneo yellow muntjac, Mouse deer, Pig-tail macaque, Long-tailed macaque, Borneo gibbon and the Giant squirrel.

Asian Forestry Company (Sabah) submitted a notification letter to the Director of EPD regarding the reduction of the total project area from 53,698.80 ha to 14,940.30 ha due to land disputes (Ref. # FSM/KM/23/08/066 dated 01/08/2023). Meanwhile, the approved EIA studies still cover the current total licensed area of 14,940.30 ha.

## Social Context:

### Social Assessment Summary

Based on the FMP, there are no settlements within the project area. Villages identified in the peripheral of the licensed area are stated in the FMP report.

### Native Customary Rights

No areas subject to native customary rights were identified within the licensed area.

Asian Forestry Company (Sabah) recognizes the concerns and rights of the communities living adjacent to the Project Area and is dedicated to minimizing and offsetting any social and environmental impacts of the project on their livelihoods.

### Identified communities that are dependent on the FMU

Based on the FMP, no settlements have been identified within the project area. However, there are ten formal settlements nearby: Kg Soniton Ulu, Kg Lingkabungan 1, Kg Binontungan Suyad, Kg Sonsogon Suyad, Kg Sungai Magandai, Kg Minisulang, Kg Sonsogon Magandai, Kg Tikalod, Kg Sonsogon Paliu, and Kg Sonsogon Mogis. Based on interviews and records, these communities remain dependent on the ecosystem services provided by the licensed area.

### Land claims, disputes & communication system

Based on records, there are several land disputes inside the licensed area. A series of land excisions occurred between 1996 and 2009 for social development projects initiated by the State Government.

In 2022, Asian Forestry Company (Sabah) took further steps to reduce the licensed management area to 15,062.20 hectares, where deduction of approximately 38,000 hectares due to claims and disputes by local communities.

The implementation of the Community Development Master Plan has become an avenue for employment and a platform to settle grievances and conflict resolution (land claims) among the local communities.

### Community Forestry Projects:

Asian Forestry Company (Sabah) is continuously giving assistance and resolving issues that affects the communities through engagements and consultations.

## Scope of Assessment
